2020 MEMBERSHIP CATEGORY DESCRIPTIONS

Family Golf: This membership is for married couples or couples whom cohabitate and their children (under 23) who will play golf. Both adults have unlimited golfing privileges, children have children's golfing privileges. All family members have access to; driving range, club tournaments and leagues, swimming pool and children's swim team, house charge account, member run organizations, discounts on selected in-house events, preferred tee times, and preferential member access to amenities.

Family Golf (Under 35): This membership is for married couples or couples whom cohabitate (aged 21-35). Both adults have unlimited golfing privileges, children have children's golfing privileges. All family members have access to; driving range, club tournaments and leagues, swimming pool and children's swim team, house charge account, member run organizations, discounts on selected in-house events, preferred tee times, and preferential member access to amenities.

Individual Golf: This membership is for one Adult (aged 35 and older) and is open to both men and women. The individual has unlimited golf privileges, access to the driving range, club tournaments and leagues and preferred tee times. The Individual's spouse and children have access to swimming pool and children's swim team, house charge account, member run organizations, discounts on selected in-house events, and preferential member access to amenities.

Individual Golf (Under 35): This membership is for one Adult (aged 31-34) and is open to both men and women. The individual has unlimited golf privileges, access to the driving range, club tournaments and leagues, driving range access, access to club tournaments and preferred tee times. The Individual's spouse and children have access to swimming pool and children's swim team, house charge account, member run organizations, discounts on selected in-house events and preferential member access to amenities.

Individual Golf (Under 30): This membership is for one Adult (aged 18-29) and is open to both men and women. The individual has unlimited golf privileges, access to the driving range, club tournaments and leagues, driving range access, access to club tournaments and preferred tee times. The Individual's spouse and children have access to swimming pool and children's swim team, house charge account, member run organizations, discounts on selected in-house events and preferential member access to amenities.

Social Golf: This membership is for an individual, married couple or couples whom cohabitate and their children (under 23). This membership includes thirty (30) 18-hole greens passes with cart to be used by anyone under the membership unrestricted on weekdays and non-holidays. Social Golf passes may be used on weekends after 10:30am. A surcharge will be applied to any round prior to 10:30am. Passes must be used first and after the passes are used, members may play by paying daily fees. Passes expire upon course closing. All family members have access to; driving range, club tournaments and leagues, swimming pool and children's swim team, house charge account, member run organizations, discounts on selected in-house events, preferred tee times, and preferential member access to amenities.

Social Golf Premier: This membership is for an individual, married couple or couples whom cohabitate and their children (under 23). This membership includes thirty (30) 18-hole greens passes with cart to be used by anyone under the membership anytime, including weekend and holidays. Passes must be used first and after the passes are used, members may play by paying daily fees. Passes expire upon course closing. All family members have access to; driving range, club tournaments and leagues, swimming pool and children's swim team, house charge account, member run organizations, discounts on selected in-house events, preferred tee times, and preferential member access to amenities.

Social & Pool: This membership is for an individual, married couple or couples whom cohabitate and their children (under 23). All family members have access to; driving range, club tournaments and leagues, swimming pool and children's swim team, house charge account, member run organizations, discounts on selected in-house events, and preferential member access to amenities.

Children's Golf Privileges: Children may play golf with the following restrictions:

Age 12 and under cannot play without an adult.

Age 16 and up with valid driver's license for cart use. Age 16 and up to play in tournaments.

Cart Leases: Seasonal cart leases are available. Cart leases provide unlimited carts for the individual (single seat). Cart leases do not include guests. Family cart leases include unlimited cart use for the individual and family members of age to operate golf carts. You may also pay daily cart rental.

PAYMENT OF MEMBERSHIP RATES:

Golf Memberships may be paid in a manner ranging from 1, 2 or 4 installments.

One (1) Payment:

Golf Members will receive eight (8) 18 hole guest pass credits

Payment in two (2) installments:

1st payment due by February 29, 2020

2nd payment due by June 30, 2020

Golf Members will receive four (4) 18 hole guest pass credits

Payment in four (4) installments:

1st payment due by February 29, 2020

2nd payment due by April 30, 2020

3rd payment due by June 30, 2020

4th payment due by August 31, 2020

No guest pass credits will be issued for electing this payment option

GUEST PASS CREDITS:

Guest pass credits for Golf Members will be distributed according to your payment option and are credited to your credit book upon first payment. Social and Social Golf Memberships do not receive Guest Pass Credits. Payment must be received by February 29, 2020 to receive guest pass credits. At the time of play with a guest, please advise the Pro to use a guest pass credit. Guest Passes are valid for unlimited golf membership categories only. Guest Passes will expire upon course closing. Guest Passes are NOT TRANSFERABLE and have NO monetary value.

LOCKER RENTAL FEES: \$120 annually per locker (optional)

CART LEASES: \$975 Family \$700 Individual \$350 Individual under 35 (subject to NYS Sales Tax)

HANDICAP FEE: \$25 (please notify the golf shop prior to June 1, 2020 if you wish to not keep a handicap)

FINANCE CHARGE: A finance charge of 2% will be charged to all accounts that are 30 days past due.

Of the remainder of the pool, the member can allocate any portion for use toward bar/restaurant charges (to be used within a 2-week period following the scoring of the hole-in-one.) Any residue will be allocated to that person's account in the Pro Shop. (No Cash will be disbursed directly to the person scoring the hole-in-one.)
